

SUNLAKE SOCCER SUMMER CAMP (SSSC)

TERMS AND CONDITIONS OF ENROLMENT

SUMMER 2017

For Understanding and permission of Parents/ Guardians

- 1. Consent.** This consent is related to the participation of your child in the SunLake Soccer Summer Camp (SSSC) at 10333 Diego Drive South, Boca Raton, Florida, managed by Boca Raton Preparatory School, Inc. You are registering online and by going through the online process you agree your child taking part in all the activities offered by the SSSC for your child's age. Notwithstanding your consent given, the SSSC will provide you with information about the proposed activity before it takes place, which will give you the opportunity to inform the SSSC if you do not wish your child to take part in a particular activity. By providing your consent you agree to your child taking part in the activities as a general consent form.
- 2. SunLake Soccer Summer Camp is addressed to children** between the ages of 3 through 14 years of age. Preschool children must be 3 years old by January 1, 2017 and toilet trained. Our C.I.T. (Camp counselor) Program is available for children ages 14-16
- 3. Health and Disability.** I confirm that to the best of my knowledge and belief my child is in good health. I am aware of no reason on medical grounds why my child should not take part in the above referred to activity. I have provided full information on any disability or special needs that might affect my child's ability to take part in the international activity or have an effect on the safety and welfare of my child or others in the party. I agree to update the SSSC in the event that my child's health, disability, or needs change.
- 4. Accident / Illness.** I consent to all emergency or other medical or dental treatment including inoculations, general or local anesthetic, surgery or blood transfusions, which, in the opinion of a qualified medical practitioner, are necessary for the safety and well-being of my child. I accept that the SSSC commits to ensure, so far as is reasonably practicable, my child's health and safety whilst on the activity. I agree to hold those people of authority harmless from any action in this respect.
- 5. Personal effects of the student.** I acknowledge that my child will be responsible for the safety of his/her own money and personal effects. The SSSC shall not be responsible for losses, unless these are caused by the negligence of the School. Please be aware the mobile phones or other items may be confiscated if used at inappropriate times and are returned back to your child at a reasonable and convenient time.
- 6. Medical Policy.** Each camper must submit the appropriate medical form, including a *Florida Certification of Immunization*, DH 680 Form and a *Physical Form* DH 3040 (Blue and Yellow Forms) from his or her doctor. During camp hours, all medications are kept in the clinic and dispensed by one of the members of our Camp Staff, as required. Parents must sign a medication permission form in the event medical attention needs to be administered.
- 7. Meals:** The standard fees for the summer camp include a well-balanced daily meal.
- 8. Images.** I give SunLake and its affiliated companies permission to photograph and/or video tape my child for use in advertising, social media and promotional materials
- 9. Child Exclusion.** On rare occasions, a child - or his/her parents - proves incompatible with the general well being of camp, e.g. bullying, disruptive or aggressive behavior. We reserve the right to exclude such children through a temporary suspension or an expulsion. No refund will be made for any remaining days booked.

10. **SunLake Soccer Summer Camp policies and procedures.** I agree to adhere to all policies as outlined by the administration of SunLake Soccer Summer Camp, including those regarding Uniforms, Pick-up/Drop-off, Refunds, and Credit Accounts. Please read the referred policies and procedures closely before registering your child to the SSSC.
11. **Equal Opportunities and Safeguarding Children.** We are an equal opportunities employer and also welcome children regardless of their gender, ability, race or religion. Each child attending camp is of equal value and is entitled to equal access of opportunity. We operate a zero tolerance policy to discrimination or bullying of any kind. SunLake Soccer Summer Camp has an obligation in relation to Safeguarding Children. As a caring organization, any suggestions of child abuse or neglect will be reported to our regulator.
12. **Special Needs – Behavioral, emotional, physical, academic or other.** It is our policy not to exclude any child due to special needs, wherever possible. The needs of each child vary, so decision are made on a case-by-case basis, depending on the level of support each individual child requires to enable them to fully enjoy activities at Camp. We request that parents of children with special needs advise us of this on the application or consent form so we can discuss how best to accommodate their child and consider whether any special arrangements need to be made.
13. **Data Protection / Privacy.** We will use your details to mail and/or email you with future information about our SSSC activities. You may opt out of our mailing list when booking or afterwards at any stage. SSSC is required to disclose such personal information by any applicable law, regulation or legal process.
14. **Liability.** I assume all rights and risks and hazards incidental to my child's participation in the activities on SunLake Soccer Summer Camp and its owners, officers, and employees.

Nothing in this form limits or excludes the SSSC's liability for death or personal injury caused by the School's negligence or the negligence of its employees, agents or subcontractors or for anything else in respect of which it would be unlawful for the SSSC to exclude or limit its liability.

I accept the SSSC shall not be liable for any loss or damage resulting from situations beyond its reasonable control.

If the SSSC fails to comply with these terms or acts negligently it is responsible for loss or damage the student may suffer that is a foreseeable result. However, the SSSC is not responsible for any loss or damage that is not foreseeable. Loss or damage is foreseeable if it was an obvious consequence of the SSSC's breach or if it was contemplated by the SSSC and me at the time of declaration.
